- 2. Housekeeping

    - i. Request by members to fix the chat. Possibly restart with the meeting with chat enabled. While working on that a member provided assistance and the chat was fixed for all except the president. Annette Miner volunteered to moderate comments/. questions for Billieanne.
    - ii. Seems one member is having problems with audio and visual on zoom.
    - iii. Board/ chairs and other speakers were spotlighted to assist all being able to see.
  - b. Check for quorum- Member Services Chair: 29 members on call- plus one non member, 150 members = yes we have a quorum of members, and of the board
- 3. Call for additions to agenda. None

  - a. President
    - i. Board and Chairs have been meeting monthly to check in between quarterly meetings (with a December break) and will continue to meet monthly throughout the rest of this FY.   - i. General Meeting and Board and Chair meeting minutes from 2017 to present are being worked on and will be posted to the website.

  - i. Quarterly financial report
    - 1. Finances stable, not much activity so far this year because of meeting restrictions
  - ii. Discussing CD investment options so we can earn some income independently of membership dues

  - i. Community Updates
    - 1. How to best serve and include BIPOC interpreters
      - a. History- Since a discussion started at the end of the June GM there has been a group of BIPOC interpreters meeting in SD virtually. I attended one of the meetings recently and

they discussed wanting to find some type of official way to have representation for issues faced. One way is having a BIPOC Rep on the board, and that is done through a bylaws change - that is being worked on. Another way is to have a BIPOC committee attached to the board and chairs - this was voted for successfully by the SDCRID board with chairs, PPMs, and more to follow. This BIPOC group has been a BIPOC space to build community and support each other and the goal is to continue that work with the support and resources of SDCRID.

## 2. Vaccine information

DCS has sent information to their interpreters, other agencies can be contacted as well to receive proof of working in hospitals if that is the case. Example of Oregon which has a medical credential (actually registry) for interpreters and all on that list are automatically prioritized. Billieanne will report out after tomorrow's meeting

    - i. New online system getting up and running.
      - 1. Only members have access to borrowing, but non members can see the library catalog. Virtual database link is available on the SDCRID website.
      - 2. Members will be added to the system but will need to complete the registration process. Registration is required to borrow material. Email invitations will be sent by the beginning of February with more information. Once you reserve an item, the Librarian will be alerted and reach out to the member to coordinate transfer of the item(s).
